- 2) Any of the above is subject to: 1<sup>st</sup> Offense: \$5,000.00 2<sup>nd</sup> Offense: \$10,000.00 3<sup>rd</sup> Offense: "Barred for life."
- 3) Tires will be confiscated. Any competitor not allowing tires to be confiscated for chemical analysis or other reason(s) under this contract will be considered illegal and all penalties apply.
- 4) Party (s) signing below may be subject to subject to criminal prosecution under laws of the Federal Government and the Department of the Environment Protection Agency (EPA).
